GENERAL INFORMATION

NOTE: There must be at least 3 Floats entered in the 2018 Halloween Parade for the Prizes to be awarded.

RULES, REQUIREMENTS FOR ALL FLOATS

Float Rules:

- Floats must be **pre-registered** to be eligible for the Prizes.
 - Proof of Insurance is required for all vehicles participating in the parade (see below).
 - **FLOATS assemble at 3:00pm**, upper level of Memorial Park, corner of Depew and Piermont Avenues.
 - **Send REPRESENTATIVE to REGISTRATION TABLE** to check in.
 - **You will be assigned a PARADE SPOT** by the PARADE MANAGER.
 - **Follow the directions of the PARADE MANAGER for all logistics:** where to park your float and when to join the Parade Line. Float participants who do not follow the directions of the Parade Manager, or who 'jump' the Parade Line, will be disqualified from the competition for Prize Money or entry into future Parades.
 - **Call Chamber Office if you need to discuss special arrangements for your Float. 845-353-2221.**
- (1) **All floats** must be registered with the Nyack Chamber of Commerce by October 22, 2018.
 - (2) **Floats / vehicles** must not exceed 13 feet in height, 5 foot width, 13 feet long. Tractor-trailers are prohibited.
 - (3) **Insurance:** Organizations and individuals entering a float or operating a motor vehicle must provide the Village of Nyack with a certificate of insurance showing not less than \$1,000,000 liability coverage and naming the Village of Nyack and Nyack Chamber of Commerce as Additional Insured.
 - (4) **All vehicles and floats** must be escorted by a minimum of four individuals. These persons should walk on the street at each corner of the vehicle to act as safety monitors to protect the public.
 - (5) **Throwing of candy, toys or other objects from vehicles or floats is strictly prohibited**, as this creates potential serious personal injury. Anyone observed violating this rule will be subject to police action and will not be eligible for participation in future events. Participants on foot may distribute candy to spectators yet are urged not to create a situation where spectators are encouraged to enter the parade route and expose themselves to the danger of moving vehicles.
 - (6) **The sale of "Silly String"** or similar items and the spraying of same by parade participants or spectators will not be permitted.
 - (7) **WAIVER:** By signing this agreement, the undersigned agrees to indemnify, defend and hold harmless Nyack Chamber of Commerce, the Village of Nyack, Orangetown Police Department and its members, directors, officers, employees, agents and representatives, and all volunteers assisting with the production and staging of the Parade from and against any personal injuries, property loss or other damage suffered by any person or entity as a result of the actions of the undersigned and/or other persons involved with the float. Parade participants accept all responsibility for their actions and those of the participants connected to their float. By registering for this event, participants acknowledge that their (including their minor children) names and/or photographs can be used by the Nyack Chamber of Commerce for event and/or publicity purposes.
